UK INKS '100 YEAR PACT' WITH UKRANE

■ Agreement includes economic aid, support for healthcare, and increased military collaboration

Sir Keir Starmer has pledged to put Ukraine in the "strongest possible position" in a trip to Kyiv where he signed a "landmark" 100-year pact with the war-stricken country.

The prime minister's visit on Thursday was at one point marked by loud explosions and air raid sirens as Ukraine's defence systems intercepted a Russian drone attack.

Acknowledging the "hello" from Russia, Volodymyr Zelensky said Ukraine would send its own "hello back".

The Ukrainian president praised the UK's commitment against the backdrop of wider concerns that US President-elect Donald Trump could reduce aid.

Zelensky is looking to firm up security guarantees from key allies as there are worries the new US administration could start pushing Ukraine to make peace with Russia.

On Thursday, the UK prime minister vowed to commit more support to Ukraine in its ongoing war effort against Russia which it has been fighting since February 2022.

"We are with you not just today, for this year or

the next - but for 100 years - long after this terrible war is over and Ukraine is free and thriving once again," he told Zelensky.

Sir Keir said the air raid that greeted him in Kyiv was a reminder of daily attacks and "the resolve of the Ukrainian people in the face of it".

Thursday's pact formalises economic and military support the UK had already promised to Ukraine.

As well as military support, including the delivery of a new mobile air defence system to be designed in the UK and funded by Denmark, the agreement includes economic aid, support for healthcare, and increased military collaboration on maritime security and drone technology.

The UK will also continue to train Ukrainian troops. More than 50,000 have been trained on British soil during the conflict so far.

In Kyiv, the two leaders

walked behind an honour guard which carried wreaths in the national colours of the UK and Ukraine.

After soldiers set down the wreaths, Sir Keir and President Zelensky placed their bouquets at the foot of the wall outside St Michael's Golden-Domed Monastery.

The Kyiv landmark is covered in photos of the dead and has become a place of pilgrimage for grieving families to pay

tribute.

When the leaders met for talks inside Kyiv's Mariinsky palace, multiple explosions and air raid sirens were heard.

The prime minister also visited an apartment building damaged in a New Year's Day drone attack, which killed a couple who had been prominent scientists. The apartment is just down the street from the president's office.

"They were sending us

a message," the head of Kyiv's military administration told Sir Keir. "No one is safe".

Sir Keir also visited a school, partnered with a sister school in Liverpool, and a hospital in Kyiv specialising in treating burns.

On the tour of the intensive care unit, he met wounded Ukrainians on a rehabilitation ward supported by the British Red Cross.

"If Ukraine falls, so does

Europe," an injured civilian who had burns across both hands and arms told the prime minister.

Sir Keir said the injuries he saw were "a grim reminder of the heavy price that Ukraine is paying".

"One of the consequences of this conflict has been to draw Nato more strongly together," he said.

Zelensky declared the visit "a truly historic day" and said "our relationship is closer than ever."

We'll fight tooth and nail to prevent Gerry Adams getting compensation, vows Starmer

■ Proposed repeal of Legacy Act could put the suspected former IRA leader 'in line for a cheque'

The government will look at "every conceivable way" to prevent former Sinn Féin leader Gerry Adams from receiving compensation, the prime minister has said.

Sir Keir Starmer was speaking in the House of Commons on Tuesday after the Conservatives said it was "shameful" that repealing the Legacy Act could put Mr Adams in line for a "cheque".

The Legacy Act presently blocks him - and many others interned without trial in the 1970s - from claiming compensation for unlawful detention.

Mr Adams was detained in the early 1970s when the government in Northern Ireland introduced internment as violence spiralled in the early years of the Troubles.

More than 1,900 people suspected of being members of paramilitary organisations were detained, but many were arrested based on flawed intelligence.

Mr Adams has consistently denied being a member of the IRA.

A clause in the act cur-

rently blocks payouts to him and about 400 other people also interned.

Labour, which has begun the process of repealing the act, said the previous government's approach to legacy was "almost universally opposed in Northern Ireland".

If the Legacy Act was repealed, it is thought highly likely Mr Adams would pursue compensation.

Several peers have backed a report by Policy Exchange, a London-based think tank, criticising moves to lift the ban.

'better framework'

In a statement following the prime minister's comments, Mr Adams said people should remain cautious about what exactly was being proposed.

He said a Supreme Court ruling in 2020 that his detention had been unlawful was "explicit".

"When the legislation is changed there will almost certainly be further legal process in the courts before there is clarity on this matter," he said. "But no one should be surprised by a British government seeking to dodge its lawful and human rights responsibilities."

Speaking at Prime Minister's Questions (PMQs), Sir Keir said the act was "unfit" because it was not supported by victims or political parties.

He referred to the Northern Ireland High Court ruling that part of the act was incompatible with human rights' legislation and the Windsor Framework.

"We will put in place a better framework, we're working on a draft remedial order and replacement legislation and we will look at every conceivable way to prevent these types of cases claiming damages and it's important I say that on the record," he said.

If Mr Adams was successful with a compensation bid, it could result in a six-figure payout.

This would cover both his unlawful detention and a prosecution for attempted escapes, for which he was sentenced to four-and-a-half years imprisonment.

Speaking after Sir Keir's comments at PMQs, his official spokesman said he could not guarantee that compensation payments to Mr Adams or other former Troubles internees would be prevented.

"Clearly the govern-

ment's intention is to prevent compensation from being paid," he said.

"We are going to look at every option but I can't get ahead of that process.

"The prime minister wouldn't make the commitment on the floor of

the House if he didn't think we could address this issue.

"It is a complex area and we have been left with a real mess when it comes to the Northern Ireland Legacy Act which was completely unfit for purpose"

UK hopes to unlock 'vast potential' of Al

LONDON (AP) — Artificial intelligence presents a "vast potential" for rejuvenating UK public services, Sir Keir Starmer said on Monday.

In a speech setting out the government's plans to use AI across the UK to boost growth and deliver services more efficiently, the Prime Minister said the government had a responsibility to make AI "work for working peo-

The AI Opportunities Action Plan is backed by leading tech firms, some of which have committed £14bn towards various projects, creating 13,250 jobs, the government said.

But the government faces questions over how much time and money will be needed to make its vision a reality, amid concerns over borrowing costs and the falling value of the pound.

The plan includes

proposals for growth zones where development will be focused, and suggests the technology will be used to help tackle issues such as potholes.

While estimates from the International Monetary Fund (IMF) support the claim that AI could increase productivity, it also says the changes may come gradually.

The government tasked AI adviser Matt Clifford with creating a UK action plan for supporting the growth of artificial intelligence and its

use in public services.

He came back with 50 recommendations which are now being implemented.

Among these is for the UK to invest in a new supercomputer to boost computing power - marking a change in strategy after the Labour government ditched the previous government's plans for a supercomputer at Edinburgh Universi-

Kate announces for first time her cancer is 'in remission'

■The Princess visited cancer patients at the Royal Marsden Hospital

The Princess of Wales has revealed she is in remission from cancer after making an emotional return to the hospital where she received treatment.

In a message posted on social media, Catherine spoke of her "relief" and said she remained "focused on recovery".

"As anyone who has experienced a cancer diagnosis will know, it takes time to adjust to a new normal. I am however looking forward to a fulfilling year ahead," the princess wrote in the post, which she signed off as "C".

Earlier, on a visit to the Royal Marsden Hospital in west London, Catherine thanked staff and empathised with cancer patients about the "tough" treatment but reassured them there was "light at the end of that tunnel".

It is the first time it has been confirmed the prin-

cess is in remission from

She announced her diagnosis last March before she revealed in September she had completed her chemotherapy, saying: "Doing what I can to stay cancer free is now my focus."

Cancer Research UK says the word "remission" means that after treatment there is no sign of the cancer.

The charity says some cancers can come back so doctors tend to use the word remission not "cure".

In her message on social media, Catherine thanked the Royal Marsden Hospital for its "exceptional" care and for looking after her "so well"

She added: "My heart-felt thanks goes to all those who have quietly walked alongside William and me as we have navigated everything.

We couldn't have asked for more."

On Tuesday morning, the princess had spoken to cancer patients at the Royal Marsden with the empathy of her own firsthand experiences, in her most significant solo royal engagement since her treatment ended.

Catherine told a woman who was having chemotherapy: "It's really tough... It's such a shock... Everyone said to me, 'please keep a positive mindset, it makes such a difference'."

Arriving as a visitor now rather than as a patient, the princess sympathised with those undergoing treatment - and described how she was still feeling the long-term effects.

"You think the treatment has finished and you can crack on and get back to normal, but that's still a real challenge," she said.

"The words totally disappear. And understanding that as a patient - yes, there are side effects around treatment, but actually there are more long-term side effects."

Asked how she was feeling, Catherine said she was doing well, but added: "Sometimes from the outside we all think you've finished treatment and you go back to things. But it's hard to get back to normal."

The princess hugged Tina Adumou, who broke down in tears as she told how her 19-yearold daughter is in the intensive care unit. Putting an arm around her, Catherine looked emotional and told her she was in the best possible place.

The princess said: "I'm sorry. I wish there was more I could do to help. I wanted to come and show my support for the amazing work that's going on here, and for those who are going through treatment and having such a hard time."

Catherine added: "Are you okay? Yes?", then said, smiling: "There is light at the end of that tunnel. Very nice to meet you and best of luck. You are in the best of hands."

The princess's visit was the first time it had been disclosed that the Royal Marsden was the hospital where she had cancer treatment.

It is almost a year since the princess's health problems were first revealed - with an announcement last January that she had undergone abdominal surgery.

Catherine then announced in a video statement in March that she was in the early stages of receiving cancer treatment - and in September released a video saying that her chemotherapy had ended.

Tributes flow for TV funny man Slattery


■ Comic was fixture on British TV for two decades

Sir Stephen Fry has led the tributes to British actor and comedian Tony Slattery, who has died aged 65 following a heart attack.

Slattery was a fixture on British television for more than two decades, and was known for his quick-witted improvisations on the popular Channel 4 show Whose Line Is It Anyway?

Sir Stephen, who also featured on the show as well as with Slattery in Cambridge University's Footlights group, described his old friend on Instagram as "the gentlest, sweetest soul" and "a screamingly funny deeply talented wit and clown".

Londoner Slattery also played comedic and serious roles in films such as crime thriller The Crying

Game, Peter's Friends and the dark comedy How to Get Ahead in Advertising.

He earned an Olivier Award nomination for best comedy performance for his role as Gordon in Tim Firth's play Neville's Island.

A statement on behalf

of Slattery's longstanding partner, actor Mark Michael Hutchinson, said: "It is with great sadness we must announce actor and comedian Tony Slattery, aged 65, has passed away today, Tuesday morning, following a heart attack on Sunday evening."

In his tribute on Instagram, Sir Stephen noted the "cruel irony that fate should snatch him from us just as he had really begun to emerge from his lifelong battle with so many dark demons".

Born into a working class family in North London in 1959, Slattery won a scholarship to study medieval and modern languages at Cambridge University.

It was from here that he entered the world of showbiz, meeting a young Sir Stephen, who invited him to join the Cambridge Footlights - the university's famous amateur dramatics club.

From then on, Slattery

once said: "Getting up on stage and hearing laughter took over."

At Cambridge, he was also a contemporary of Dame Emma Thompson and Hugh Laurie.

In 1981, the group won the inaugural Perrier Comedy Award at the Edinburgh Festival, for their cont. on page 4, col. 1

production of The Cellar Tapes.

And the following year, Slattery was named Footlights' President, following in the footsteps of Eric Idle, Clive Anderson and Peter Cook.

Slattery went on to appear on the London club circuit doing "kind of a variety act with bizarre turns" as he put it.

He made several TV appearances, including a stint hosting children's program TX.

But his big break came in 1986, when he landed a starring role in the West End musical Me and My Girl; before going on to appear in Radio Times, Privates on Parade and Neville's Island – to critical acclaim.

in the country and "has the potential to transform the lives of working people".

"We're going to make AI work for everyone in our country," he added, saying the "battle for the jobs of tomorrow is happening today".

Sir Keir said the UK would become one of the AI "superpowers" - mirroring former Prime Minister Rishi Sunak's drive to boost the UK sector so it could rival that of the US and China.

The Sunak government's emphasis on "safety" seems largely absent in this new planinstead focusing on maximising opportunities, growth and innovation.

The pivot away from the previous narrative of caution and safety suggests the government has decided the UK should attempt to compete in the AI arms race, currently lead by major global players including the US and China.

Shocking nobody, Sturgeon and hubby announce split

Former First Minister Nicola Sturgeon and ex-SNP chief executive Peter Murrell have "decided to end" their marriage.

In a social media post, Sturgeon said the pair had been separated for some time.

Murrell was charged with embezzling SNP funds in April as part of a police investigation into the party's finances.

Sturgeon was arrested and released without charge in June 2023. She insists she has done nothing wrong.

The former first minister said the decision to end the marriage had been made "with a heavy heart".

She posted on Instagram: "To all intents and purposes we have been separated for some time now and feel it is time to bring others up to speed with where we are.

"It goes without saying that we still care deeply for each other, and al-

ways will."

Sturgeon said the pair would not comment further.

The couple first met at an SNP youth event in 1988 and had been together since 2003.

They married at a ceremony in Glasgow, where they shared a home together, in 2010.

Sturgeon unexpectedly announced her resigna-

tion as first minister and SNP leader in February 2023 after eight years in office.

She denied her decision was influenced by the police investigation.

Murrell resigned as SNP chief executive in March 2023, having held the post since 2001.

He quit after taking responsibility for misleading the media about party

membership numbers.

Operation Branchform

Police Scotland has spent more than two years looking into what happened to £660,000 of donations given to the SNP by independence activists.

Sturgeon and Murrell's Glasgow home was searched by officers in April 2023.

Police also searched the SNP's headquarters in Edinburgh and confiscated a luxury motorhome parked in the driveway of Murrell's mother in Fife.

In September last year it emerged that officers had sent prosecutors details of what they had uncovered in an "advice and guidance report" and were seeking formal advice on what they should do next.

The update was understood to be about Sturgeon and ex-SNP treasurer Colin Beattie, who have both remained under investigation after being arrested and released without charge in 2023.

At the time, the Crown Office and Procurator Fiscal Service (COPFS) said the police report was under consideration.

Police Scotland has said it is awaiting direction from COPFS "on what further action should be taken".

Linda Nolan succumbs to cancer at 65

■ Singer found fame in the 1970s as part of the Nolan Sisters

Singer Linda Nolan, a member of pop group the Nolans, has died at the age of 65, two decades after she was first diagnosed with cancer.

Nolan found fame in the 1970s alongside sisters Coleen, Maureen, Bernie, Denise and Anne, and they scored hits including the 1980 disco classic I'm In The Mood for Dancing.

She was diagnosed with breast cancer in 2005 and given the all clear in 2011, but in 2017 was diagnosed with secondary breast cancer. It spread and by 2023 was in her brain.

TV presenter Coleen Nolan said she was "utterly devastated" by her sister's death, describing Linda as a "beacon of love, kindness and strength".

"Her wit, humour and laughter was infectious,

her presence could light up any room," Coleen said in her tribute on Instagram.

"Linda had a heart full of compassion and always knew how to bring comfort and joy to those around her."

The Nolan Sisters became the first Irish act to sell more than a million records worldwide, and went on to sell 30 million records in total.

Their other hits included Gotta Pull Myself

Together and Attention to Me.

Nolan left the group in 1983, but later reformed with her sisters for several comeback performances.

Loose Women presenter Christine Lampard announced Nolan's death on Wednesday's episode of the ITV daytime show, describing it as "very sad news".

Co-panellist Nadia Sawalha said it was an "awful shock" and said

the show's team was "sending our love".

'massive talent'

Nolan appeared on the programme a number of times, and her sister Coleen is a regular panellist

Linda also appeared in a West End production of Blood Brothers, was a Daily Mirror columnist and wrote a best-selling memoir.

Although she had been ill for some time, she maintained a sense of optimism.

Speaking to the Mirror last month, she said: "I thought my 60th birthday would be my last, but I'm still here, five years later. It's easy to sit back and get depressed about it, but I'm still going."

MOTD: BBC decides it takes three to fill Lineker's shoes

■ Cates, Chapman and Logan to rotate atop flagship football show

Kelly Cates, Mark Chapman and Gabby Logan will be the new Match of the Day presenters from next season, the BBC has announced.

It is the first time the role will be shared between three people.

They will split presenting duties for Match of the Day 2 on Sundays and MOTD: Champions League on Wednesdays, as well as Saturday's flagship show all shows are available to US viewers on the iPlayer app although you will likely need a VPN (Virtual Private Network)

Gary Lineker has hosted Match of the Day since 1999 and will do so for the rest of the season.

The former England striker will continue to lead the BBC's TV coverage of the FA Cup next season and present the men's World Cup in 2026.

Cates, Chapman and Logan will be the sixth set of main presenters for Match of the Day, which is the longest-running football show in the world having launched on 22 August 1964.

Last season, 33 million viewers tuned in across all Match of the Day Premier League and FA Cup programmes.

Former England players Alan Shearer and Micah Richards will continue as regular MOTD pundits.

BBC Sport director Alex Kay-Jelski said: "I know viewers will love these three incredible broadcasters and journalists at the heart of our football coverage next season.

"They're brilliant at what they do and MOTD viewers can be sure they will be well looked after as the big football talking points are expertly analysed.

"Gary has done a phenomenal job at Match of the Day for the last 25 years, he'll be missed greatly and we all still get to enjoy him on our screens across some of football's greatest tournaments.

"Outside of Match of the Day we've got some great new shows, voices and surprises lined up for the 2025-26 season across audio, video and digital and we look forward to sharing them with you all later in the year.

"It's a truly exciting time for BBC Sport's football coverage.

"We are all friends and we've known each other for a long time and that's a really lovely part of it,"

said Cates, who will also continue to work for Sky Sports.

"Not only is it a great role just on its own but I'm sharing it with two people I really admire, respect and genuinely like. It's a great set-up."

Logan, who first joined the BBC in 2007, has stood in for Lineker on Match of the Day and presented many huge sporting events for the BBC, including men's and women's World Cups and European Championships, the Six Nations and Olympics.

"I think what's interesting is although we're sharing the role, we won't actually be working together on Match of the Day," she said.

"It's really great to share it because we bring different experiences and different interests within the game. We bring different ways of broadcasting and that will mean our pundits are kept on their toes and share different kinds of analysis."

Chapman has been the main MOTD2 host since 2013 and works regularly on BBC Radio 5 Live.

"People might find this hard to believe but there's absolutely no competition between the three of us,"

"We'll do a mix of everything that works for us all as individuals, and all of us are really keen that it's fair.

"This isn't about the three of us, it's about the three of us plus our pundits, plus our editors, plus our analysts and stats people and production people and radio people

and online."

Logan - a rhythmic gymnast for Great Britain before going into broadcasting - described it as an "iconic show".

She added: "One of the first things I did when I came to the BBC was fill in on Match of the Day and at that point when I was in that chair at the old BBC studio in London and

hearing the music, it was a real hairs-on-the-backof-the-neck moment.

"Everybody understands the history of the programme and the consistently huge audiences that watch it. It has more to offer as well - we know how strong the digital offering is and Match of the Day is really relevant to that audience too."

BAFTAS: Conclave and Emilia Perez lead the pack

LONDON: Papal thriller Conclave, which stars Ralph Fiennes as a cardinal overseeing the election of a new pope, leads the race - just - for the British Academy Film Awards, with nominations in 12 categories, one more than the genre-busting musical Emilia Perez.

But with the wildfires in Los Angeles over the past week fresh in the minds of everyone in the movie industry, Wednesday's announcement of the latest BAFTA nominations was restrained.

"Before we begin, on behalf of everyone at BAFTA, our thoughts are with colleagues, friends and peers and all those affected by the devastating wildfires in the Los Angeles area," actor Will Sharpe said before he and fellow actor Mia McKenna-Bruce announced the nominations.

BAFTA chair Sara Putt would not say whether the fires may impact the

ceremony, which is due to take place Feb. 16 at the Royal Festival Hall in London, hosted by Scottish actor David Tennant.

"The ceremony is a month away. It would be inappropriate and far too early to say anything about that," Putt told The Associated Press.

The five films nominated for the best film award were Conclave, Emilia Perez, the 215-minute postwar epic The Brutalist and the Palme d'Or-winning comedy/drama Anora, plus the Bob Dylan biopic A Complete Unknown.

"The Brutalist" had nine nominations, including leading actor for Adrien Brody, who faces stiff competition from Fiennes and Timothee Chalamet, who plays the young Dylan in "A Complete Unknown."

The other actors nominated are Hugh Grant for his creepy role in the horror film Heretic, Colman Domingo in real-life prison drama Sing Singand Sebastian Stan for his portrayal of a real estate mogul - a certain Donald Trump - in The Apprentice





half, but once again lacked the cutting edge to completely put the game to bed.

And although they closed out the win to keep themselves firmly in the title race, they were almost caught right at the end when Pedro Porro hit the outside of the post from a tight angle.

And this was a reflection of how Arsenal, even though they got a vital victory that keeps them on the heels of pacesetters Liverpool, made this a lot more difficult than it needed to be.

The sight of Gabriel hurling his shirt into the crowd showed just how important these three points were after two huge cup disappointments at home, but Arsenal still suffered familiar flaws that made the closing stages needlessly tense.

Arsenal dominated huge portions of this game - but to win it, they needed another set-piece and a shot by Trossard that should have been saved by Kinsky.

No-one could question the commitment and desire from Arsenal, or their superiority over a labouring Spurs, but once again a lack of cutting edge and a habit of over-elaborating when they got into danger areas drew groans of frustration from their supporters.

It is still obvious, however, that if the latest Arsenal title challenge falters, it will be because of the lack of a reliable striker, especially with Bukayo Saka still on crutches after hamstring surgery and Gabriel Jesus ruled out for the long term with a serious knee injury.

Potter celebrates 'togetherness' after first Hammers win

Graham Potter says he is building a "foundation of togetherness" at West Ham after a clinical midweek display helped them beat Fulham in the Premier League for his first win as head coach.

The Hammers were outplayed in the opening exchanges as Harry Wilson hit the bar for the visitors, but then the game swung in three first-half minutes.

Having already had a goal disallowed for offside, West Ham went ahead when Carlos Soler capitalised on a loose pass to curl home.

Moments later, a long ball over the top ended in Aaron Wan-Bissaka cutting back for Tomas Soucek to flick into the roof of the net.

Fulham again hit the bar through Raul Jimenez before Alex Iwobi pulled one back, curling all the way in from the left flank as Jimenez put Lukasz Fabianski under pressure.

West Ham's two-goal advantage was restored when Lucas Paqueta tucked home a loose pass after Danny Ings forced Fulham goalkeeper Bernd Leno into an error.

Iwobi ensured it was a nervy finish when another cross drifted all the way in.

Fulham had a golden chance to equalize in stoppage time when a cross fell for Adama Traore, but he blazed over the bar from five yards.

"The start point is the foundation of togetherness and the foundation of a team," Potter said after the game.

"We were far from perfect. But in terms of application of the players and how they fought and suffered, they were really, really, good.

"We have to look at the context of what happened and it's been a tough week for the players and we have players missing, especially in the forward areas.

"But nevertheless, the team spirit, the team effort and willingness to try were fantastic."

United and Tottenham, and move 10 points clear of the drop zone.

Fulham, who had been unbeaten in their past eight Premier League games, are ninth.

Potter was beaming with delight as the full-time whistle rang out at the London Stadium.

The former Brighton and Chelsea boss will have had little time to work with his players since taking over on Thursday, but there were already signs of improvement.

All of the pre-match talk was about their desperate search for a striker after the injury suffered by Niclas Fullkrug in Friday's FA Cup defeat by Aston Villa, to add to the absence of Michail Antonio after his car accident.

They were clinical here though, with their four shots resulting in three goals.

Admittedly they were helped twice by Fulham mistakes, but goals from three midfielders will delight Potter.

There will be concerns

at the other end of the pitch though, with two goals easily conceded again.

West Ham have the fourth worst defensive record in the Premier League and Potter will have to tighten that up soon if he wants them to climb the table.

Speaking to about Potter's impact, Soucek said: "Things are going very fast with the new manager and the new style.

"I would say I was so happy with how we fought as a team."

"Great to be back" says Moyes after taking over at Everton

David Moyes said it is "great to be back" after being appointed Everton manager for a second time

The 61-year-old Scot has signed a two-and-a-half-year contract at Goodison Park following the sacking of Sean Dyche on Thursday.

Everton are 16th in the Premier League - one point clear of the relegation zone - with only three wins from 19 games this season.

"I enjoyed 11 wonderful and successful years at Everton and didn't hesitate when I was offered the opportunity to rejoin this great club," said Moyes.

"Now we need Goodison and all Evertonians to play their part in getting behind the players in this important season so we can move into our fabulous new stadium as a Premier League team."

Moyes managed Everton from 2002 until 2013 before spells in charge of Manchester United, Real Sociedad, Sunderland and West Ham twice.

He has been out of work since leaving West Ham, where he won the Europa Conference League in 2023, at the end of last season

Moyes spent 11 years at Everton before leaving to take charge of United as Sir Alex Ferguson's successor in the summer of 2013.

Following a four-year spell at Preston, he joined Everton in March 2002, with the Toffees in danger of relegation.

Moyes won his first match and went on to take charge of more than 500 games.

Everton reached the FA Cup final in 2009 and fin-

ished in the top eight of the Premier League nine times, including fourth in 2004-05, which took them into Champions League qualifying.

Moyes gave Wayne Rooney his professional debut and signed several players who would become Everton greats, including Tim Cahill and Marouane Fellaini. Moyes was handpicked by Sir Alex as his successor at Old Trafford but failed to see out the 2013-14 season.

He was sacked in April 2014 after 10 months in charge, with United seventh in the table and unable to qualify for the Champions League.

Moyes helped West Ham avoid relegation in 2017-18 during a sixmonth spell in charge.

Moyes returned to West Ham that month following the sacking of Manuel Pellegrini, and remained in charge until the end of the 2023-24 season.

In that time he led them to two top-seven finishes and won the Europa Conference League, their first major trophy for 43 years.

'AMAD' RUSH RESCUES POOR DEVILS

■ Diallo late show delivers another heart-stopping victory for United

Amad Diallo scored a stunning late hat-trick Thursday night as Manchester United turned what seemed certain to be a humiliating defeat into a thrilling 3-1 victory over Southampton at Old Trafford.

United appeared to be heading for a fourth consecutive top-flight home defeat for the first time since 1930 as they laboured badly trying to overcome a Southampton side who had won just once all season and suffered a 5-0 home loss to Brentford on their last league outing.

But Diallo, a week after signing a new fiveand-a-half-year contract, had other ideas.

The Ivorian, moved into an attacking role from the wing-back position he started the contest

in, took the game by the scruff of the neck, levelling nine minutes from time. He surged into the box, profited from a fortunate break of the ball and drove the rebound past Aaron Ramsdale.

A minute into stoppage time, Diallo kept running on to Christian Eriksen's chipped return pass before beating Ramsdale with a first-time effort.

And he capitalised Taylor when Harwood-Bellis failed to control Ramsdale's pass, nipping the ball away from the former Manchester City defender and passing the ball into an empty net to complete his first senior hat-trick.

"He did a great job. But he has a lot to improve," head coach Ruben Amorim said after the game. "He has the same responsibility as every player who play for Manchester United

"He is in a great moment and he is having a very good season."

It was awful luck on Southampton, who deserved so much more for their efforts but all they had to show was a Manuel Ugarte own goal from a corner.

United, for long periods, showed Amorim was right to express his concerns about his side's effectiveness against lesser opposition after encouraging performances against Liverpool and Arsenal.

But Diallo, who has responded better to Amorim's arrival than anyone else at Old Trafford. was not to be denied and walked away with the match ball in celebration

It has taken Amorim 14 games to get the full Manchester United experience.

after United's ability to score late goals under former manager Sir Alex Ferguson - to really know what it means to be in charge of United.

Amorim will know for 80 minutes, his side were absolutely awful.
