Starmmer pledges British troops to support Ukraine

■ PM "ready and willing" to use Armed Forces to secure lasting peace deal

Sir Keir Starmer has said he is "ready and willing" to put UK troops on the ground in Ukraine to help guarantee its security as part of a peace deal.

The UK prime minister said securing a lasting peace in Ukraine was "essential if we are to deter Putin from further aggression in the future".

Ahead of an emergency summit with European leaders in Paris on Monday, Sir Keir said the UK was prepared to contribute to security guarantees to Ukraine by "putting our own troops on the ground if necessary".

"I do not say that lightly," he wrote in the Daily Telegraph. "I feel very deeply the responsibility that comes with potentially putting British servicemen and women in harm's way."

Sir Keir added: "But any role in helping to guarantee Ukraine's security is helping to guarantee the security of our continent, and the security of this country."

The end of Russia's war with Ukraine "when it comes, cannot merely become a temporary pause before Putin attacks again", he said.

This means UK troops

could be deployed alongside soldiers from other European nations alongside the border between Ukrainian-held and Russian-held territory.

Sir Keir has previously only hinted that British troops could be involved in safeguarding Ukraine after a ceasefire.

Health Secretary Wes Streeting said the government views the war in Ukraine as "the frontline for Europe and the frontline for Britain".

'very clear mandate'

He told the BBC that the UK is "prepared to play its part in securing the long-term future for Ukraine, for Europe and for Britain's national security".

The prime minister's announcement comes after the former head of the Army, Lord Dannatt, told the BBC the UK military was "so run down" it could not lead any future peacekeeping mission in Ukraine.

Dannatt said sending troops to Ukraine would come at a "considerable

cost" and require an increase in funding for the military.

"Frankly, we haven't got the numbers and we haven't got the equipment to put a large force onto the ground for an extended period of time at the present moment," he said.

Former MI6 chief Sir John Sawers also warned that any peacekeeping force sent to Ukraine after the war must have "a very clear mandate" to ensure a ceasefire agreement holds.

Sir Keir, who is due to visit President Donald Trump in Washington later this month, said a "US security guarantee is essential for a lasting peace, because only the US can deter Putin from attacking again".

Writing in the Telegraph, Sir Keir added that "peace cannot come at any cost" and "Ukraine must be at the table in these negotiations, because anything less would accept Putin's position that Ukraine is not a real nation".

He added: "We cannot

have another situation like Afghanistan, where the US negotiated directly with the Taliban and cut out the Afghan gov-

ernment" - in reference to a deal negotiated in Trump's first administration, which was later enacted by the Biden ad-

ministration.

"I feel sure that President Trump will want to avoid this too," said Sir Keir.

PM deflates Zelensky 'dictator' claim

Prime Minister Sir Keir Starmer has backed Volodymyr Zelensky as a "democratically elected leader" after Donald Trump described the Ukrainian president as a "dictator".

Sir Keir called Zelensky on Wednesday evening and told him it was "perfectly reasonable" for Ukraine to "suspend elections during wartime as the UK did during World War

Two", Downing Street said.

The US president had earlier criticised Zelensky, saying he had done a "terrible job" and claiming "he refuses to have elections" in Ukraine.

Zelensky's five-year term was due to end in May 2024, but elections have been suspended since martial law was declared after Russia's invasion.

Sir Keir will travel to Washington DC next week for his first in-person meeting with Trump.

The PM has said he wants to use his meeting next week to discuss a "US backstop" that he says is necessary to deter Russia from attacking Ukraine again.

But the deepening rift between the US and Ukraine has now

increased the political jeopardy for him.

In his phone call with Zelensky, Sir Keir "stressed the need for everyone to work together", a Downing Street spokesperson said.

"The prime minister reiterated his support for the US-led efforts to get a lasting peace in Ukraine that deterred Russia from any future aggression," they added.

Zelensky said they had discussed "upcoming plans and opportunities", adding: "UK's support matters indeed, and we will never forget the respect the British people have shown for Ukraine and our citizens."

There has been widespread criticism of Trump's comments around the world - including from Sweden's prime minister as well as German Chancellor Olaf Scholz, who said it was "simply wrong and dangerous".

Trump's former vice-president, Mike Pence, also criticized the comments, posting on X: "Mr President, Ukraine did not 'start' this war. Russia launched an unprovoked and brutal invasion claiming hundreds of thousands of lives."

First arrest under abortion clinic protest ban

A 74-year-old woman has become the first person to be arrested and charged under a Scottish law banning protests outside abortion clinics.

She was arrested close to the Queen Elizabeth University Hospital in Glasgow and was charged in connection with breach of an exclusion zone.

Officers removed a sign from the area - which had been held by the woman who was arrested - that read "coercion is a crime, here to talk, only if you want".

The Abortion Services (Safe Access Zones) Act

came into force last year.

The legislation prevents any protests or vigils taking place within 200m (656ft) of 30 clinics offering abortion services in Scotland.

US Vice-President JD Vance took aim at the bill last week, incorrectly claiming people who live within safe access zones had been sent letters by the Scottish government warning them about praying within their homes.

First Minister John Swinney said Vance's claims were "just wrong".

The Scottish government said no letters had

been sent out saying people couldn't pray in their homes, and only "intentional or reckless

behaviour" was covered by the act.

The vice-president was accused of "spread-

ing misinformation" by Scottish Greens MSP Gillian Mackay, who drew up the law.

Joe Haines, the first Westminster spin doctor, dead at 97**■ The lifelong Labour supporter was Harold Wilson's fiercely loyal and acid-tongued press secretary**

Joe Haines, political journalist and press secretary to former Labour Prime Minister Harold Wilson in the 1960s and 1970s, has died aged 97, a Labour spokesman has confirmed.

A "lifelong Labour supporter, who was fiercely proud of his working class background", Haines had a reputation for "toughness and loyalty in equal measure", the spokesman added.

Tony Blair's former press secretary Alastair Campbell paid tribute to him as a "superb tabloid

writer" with "acute political judgement".

Haines, who died at his home in Tunbridge Wells, Kent, had been ill for some time and had lost his sight but had remained mentally sharp, Labour said in a statement.

Haines grew up in what he later called the "bug-ridden, gas-lit slum" of pre-war Rotherhithe, south-east London.

His father died when he was young and he was brought up in poverty by his mother, an

upbringing he said drew him to join the Labour Party during his teenage years.

His career in journalism began at the age of 14 at The Bulletin, a Glasgow-based mid-morning title, where he rose up the ranks to become its political correspondent.

When it ceased publication in 1960 he became political correspondent at The Scottish Daily Mail.

From there he joined new title The Sun, then a left-leaning broadsheet, in the years before it was acquired by Rupert Murdoch.

It was from here that he was recruited by Wilson to work in Downing Street, becoming the then-prime minister's deputy press secretary and then press secretary in 1969, in what would be the final year of his first spell in power.

"A fast and brilliant writer with an acerbic tongue, he won a reputation for toughness and loyalty in equal measure," Labour said in a statement.

"After Wilson left office, Joe wrote a contro-

versial best-seller about his time in politics, The Politics of Power. He later joined the Daily Mirror, rising to become group political editor, assistant editor and a non-executive director under Robert Maxwell,

whose authorised biography he authored.

"In retirement, Joe continued to take a close interest in Labour politics, offering advice privately and publicly to the party and its leaders," the statement added.

Army 'covered up sex assault complaint' before female soldier's suicide, coroner tells inquiry

■ Army's handling of victim's complaint played "more than a minimal contributory part in her death", coroner rules

The death of a soldier left terrified after being sexually assaulted by her superior was, in part, caused by the British Army's handling of her complaint, a coroner said this week.

Royal Artillery Gunner Jaysley Beck, 19, was found hanged in her barracks at Larkhill Camp in Wiltshire on 15 December 2021 after a Christmas party.

Gunner Beck had filed a complaint against Battery Sergeant Major Michael Webber after he "pinned her down" and tried to kiss her at a work social.

On Thursday Assistant Coroner Nicholas Rheinberg ruled she died by suicide and determined the Army's handling of the complaint played "more than a minimal contributory part in her death". The Army said it "accepts the failings identified by the service inquiry".

ry".

The inquest was told the 19-year-old, originally from Oxen Park in Cumbria, had also been subjected to relentless harassment from her line manager, Bombardier Ryan Mason.

Mr Mason sent Gunner Beck more than 4,600 messages confessing his feelings for her, and showed her a 15-page "love story" he had written, detailing his "fantasies about her".

Brigadier Melissa Emmett, head of the Army personnel services group, formally apologised on behalf of the Army and said it "should have done so much more to support and protect her".

The incident in question occurred at an adventure training exercise at Thorney Island, near Emsworth in Hampshire, in July 2021.

The work gathering extended into the early

hours of the morning until Gunner Beck and Mr Webber were left drinking together alone.

Gunner Beck claimed Mr Webber told her he had been "waiting for a moment for them to be alone", and had engaged her in a drinking game called Last Man Standing before grabbing her leg and trying to kiss her.

Shortly after, Gunner Beck called her friend Lance Bombardier Kirsty Davis, "frightened and in tears" because "someone tried it on with her", the inquest was told.

She had hidden in a toilet cubicle with her feet up, before spending the remainder of the night in her car on the phone to Ms Davis out of fear he would find her.

The following morning, Gunner Beck reported the incident to Captain James Hook, who said he believed she was "gener-

ating an excuse" to leave Thorney Island.

The coroner said Captain Hook put pressure on her to drop the allegations, and only reported it to higher command "when the cat was already out of the bag".

"Hook made the clear the career ramifications [for Mr Webber], and pointed out there were no witnesses," Mr Rheinberg said.

The inquest heard a subsequent "miscommunication" through the chain of command meant details concerning Mr Webber's attempt to touch Gunner Beck's leg

were lost.

The incident therefore fell into minor sanction territory and required no formal investigation.

The coroner said despite toxicology tests showing Gunner Beck was three times over legal drink drive limit at the time of her death, he believed she had intended to take her own life.

He said: "My conclusion is she died by suicide. I am satisfied Jaysley undertook the physical actions that resulted in her death by hanging, the inevitable consequences must have been known to Jaysley despite the level

of alcohol she had consumed.

"I am satisfied she intended to die."

Jaysley Beck's mother, Leighann McCready, said: "Jaysley was so much more than a soldier - she was our daughter, a sister to Emily and a friend to so many.

"She was kind, caring and truly loved by everyone who knew her. She was full of life, bright and absolutely fantastic at her job.

"The army itself has said exactly the kind of person they wanted to join - she should still be here."

Wolves should be reintroduced to Highlands to spur woodland growth, new study suggests

Sea Eagles have had a revival, beavers are back, and whales are being spotted all over the English coast. Next up on the UK's roster of animal resurgences? Wolves... maybe.

A new study has suggested that reintroducing grey wolves to the Scottish Highlands could have a huge positive impact on its woodlands and Scotland's efforts to achieve net-zero.

Researchers at Leeds University say that bringing back the creatures would keep red deer populations under control, meaning that the tree saplings they eat would be allowed to grow, forests could regen-

erate naturally and more carbon dioxide could be absorbed.

It's thought that Scotland's last wild wolves went extinct around 250 years ago, leaving red deer with no natural predators. The deer population has soared over the past 50 years and, because they munch on practically everything in their path, they've been a big bane in rewilding and net-zero efforts.

apex predators

The new study reckons that 160 wolves would be enough to make a difference to the deer problem. But there are farmers and other members of rural communities who

aren't so keen on the idea - wolves are fierce apex predators after all.

At this point the study is just a recommendation. There are no official plans to start bringing wolves back to Scotland any time soon.

Lee Schofield, a co-author of the study, said: "Our aim is to provide new information to inform ongoing and future discussions about the possibility of wolf reintroductions both in the UK and elsewhere.

"We recognize that substantial and wide-ranging stakeholder and public engagement would clearly be essential before any wolf reintroduction could be considered.

'Human-wildlife conflicts involving carnivores are common and must be addressed through public policies that account for people's attitudes for a reintroduction to be successful.'

It is widely accepted that wolves were officially eradicated from Scotland about 250 years ago, though the exact year is

not known. This left red deer with no natural predators, and while efforts have been made to keep the population under control, it has increased over the last 100 years to an estimated 400,000 today in Scotland alone.

The researchers said only 4% of Scotland was covered by native woodland today, making it one

of the least natively forested places in Europe.

The wolf population in western Europe is about 12,000, and the animals occupy 67% of their former territory.

The researchers have said they expect some backlash to their research, particularly from deer stalkers and farmers concerned about livestock.

British teen 'tricked by parents' into going to African boarding school

A 13-year-old boy has taken his parents to court after they 'abandoned' him at a boarding school in Africa over fears he was 'joining a London gang'.

The teenager has started the family court case himself to try and return to his home in the UK, claiming his parents have 'physically and emotionally abandoned' him.

A 13-year-old boy has taken legal action against his parents, who he says tricked him into going to their birth country of Ghana and abandoned him at a boarding school.

The British teenager claims his parents told him they were traveling abroad to visit a sick relative, but he was then left there without warning due to fears that he was participating in gang activity in London—an allegation the boy denies.

The boy, who has lived in the UK since birth, reached out to the British Consulate and a child welfare organization for help. His legal team argued in court that his parents "physically and emotionally abandoned" him in an environment where he allegedly faces inadequate food, poor education, and mistreatment.

quate food, poor education, and mistreatment.

"There is clear evidence that he is being harmed emotionally, psychologically, and possibly physically in the environment in which he has been placed," Deirdre Fottrell KC, the attorney representing him said. She called the parents decision "stark and quite brutal," and argued that, as a result, their son is "upset, confused, and distressed."

The boy's father's legal team defended the move as a legitimate act of parental responsibility, citing "real concerns about where he was and who he was with" in London over his deteriorating behavior and vulnerability to criminal influences in London. They argued that the boarding school in the African country provided a safer, structured environment.

The legal team representing the teen has requested that a judge order his return to the UK, while his father's representation claims the parents acted in the child's best interest and their decision should be respected.

The hearing is ongoing.

Polish woman who claimed to be Madeleine McCann arrested

A Polish woman who claimed to be Madeleine McCann has been arrested at Bristol Airport.

Julia Wandelt, 23, was detained alongside a 60-year-old woman from Wales on suspicion of stalking involving serious alarm and distress.

Surjit Singh Clair, Ms Wandelt's PR representative, confirmed she was arrested after arriving in Bristol on the evening of 19 February.

Officers from Leicestershire Police are investigating the allegation

End times: rowdy patrons force Essex librarians into wearing body cameras

Librarians at the Witham Library in Essex may start wearing body cameras to "protect staff" following a streak of abusive behavior from patrons.

Despite hiring a security guard, the library has been plagued by an increasing number of local teens causing disruptions across the facility, Essex Live reported.

"When they are in there, they can often be causing a nuisance to other library users, and they also are not being the most polite to members of staff and, unfortunately, the security guard who we have in the library, which is also quite sad. It is a very sad state of affairs to have bodycams on librarians," Essex County Council Member Ross Playle told the outlet.

"If you had told me a few years back that librarians would be wearing bodycams and our libraries would have a dedicated security employee, I would have

thought it was bizarre," he added.

The ongoing disturbances are symptomatic of a larger issue as teens across the county shoplift from local business-

es and cause mayhem at other libraries in the area, forcing one facility to install doors recommended by police to curb "antisocial behavior."

Wales on verge of Greyhound racing ban

Wales will become the first nation in the UK to ban greyhound racing.

It comes after a petition to ban the sport in Wales received over 35,000 signatures, resulting in a Welsh Government consultation which received over 1100 responses, with two thirds being in favour of the ban.

Speaking in the Senedd on Tuesday, the Deputy First Minister, Huw Irranca-Davies said "I believe that now is the right time to move to ban greyhound racing in Wales.

"I want a ban to come into force as soon as practicably possible.

"There will be work to do in ensuring the dogs, their owners, and those involved in the industry around the racetrack, can wind down from this activity while still protecting the welfare of dogs currently within the industry, the local community and the local economy."



GREYHOUNDS: 'an ancient and noble breed'

Many animal welfare charities have campaigned for this change.

Vanessa Waddon, Chief Executive Officer of Hope Rescue has responded to the Deputy First Minister statement by saying, "we're delighted that the Welsh Government have agreed that the only way to fully protect greyhounds is to end this inherently dangerous activity."

She added, "Wales is once again leading the way on animal welfare." Greyhound Rescue

Wales CEO, Tim Doyle has said "this is a momentous day for greyhounds, an ancient and noble breed whose very recent history has been blighted by this cruel and unnecessary gambling product."

"We are now hard at work with our partner rescues to coordinate and manage the rehoming of dogs leaving the industry, and we are committed to ensuring that no dog is made homeless by the end to greyhound racing in Wales."

However, the Chief Executive of the Greyhound Board of Great Britain, Mark Bird has responded to the statement saying this news is 'hugely disappointing'.

"This announcement has nothing to do with greyhound welfare and everything to do with pressure from the extreme animal rights movement.

"The Welsh Government's own summary of consultation responses highlighted the lack of evidence to support the case for a ban on the sport. This summary made clear there has been a coordinated campaign against licensed greyhound racing, seeking to drown out the voice of local people including those whose livelihoods rely on the sport.

"Questions should be asked as to why, despite repeated requests, the minister has failed to meet with the industry in Wales."

Glaring issue: RAC seeks to dim 'too bright' British headlights

The Royal Automobile Club is calling on the Government to commission an independent study into the issue of headlight glare after new research found 85% of those affected believe the problem is getting worse.

An RAC survey of 2,000 drivers found a huge nine-in-10 (89%) think at least some headlights on cars on the UK roads are too bright, of which three-in-10 (28%) – a higher proportion than ever – think most are.

Of the all these drivers who complain about the brightness of car headlights, some 91% say they get dazzled when driving with three-quarters (74%) saying this happens regularly.

When it comes to the effects of glare on drivers, two-in-three (67%) who

suffer say they have to slow down considerably until they can see clearly again, while a similar proportion (64%) believe some headlights are so bright they risk causing accidents.

In fact, five per cent of these drivers state they have nearly been involved in a collision themselves.

Alarming, nearly one-in-10 (7%) say they find headlight glare so bad that they avoid driving at night altogether, a figure that rises to 14% for drivers aged 65 and over.

While the RAC has been surveying drivers on dazzling headlights since 2018, these new findings show more drivers than ever appear to be suffering from them, with 85% of those affected stating they believe the problem is getting worse.

Ms Wandelt claimed to be the missing Madeleine McCann in an Instagram post in 2023.

Months later she took a DNA test that showed she was from Poland, with some Lithuanian and Romanian heritage. In other words, she is

not Madeleine McCann.

Mr Clair said the 23-year-old and her companion had travelled to the UK for a few weeks to stay with a friend.

He said his client denies the stalking allegations.

Madeleine McCann's disappearance at the age of three in Portugal in 2007 - which remains unsolved - is one of the most widely reported in history.

The Oxfordshire-born actor played various characters in the comedy films which included Carry On Doctor, Carry On Up The Khyber and Carry On Camping.

His theatrical agency, Sharkey and Co, said he died on Sunday at the Royal Bournemouth Hospital in Dorset.

Holloway had a daughter, supermodel-turned-author Sophie Dahl, with British actress Tessa Dahl, daughter of children's author Roald Dahl.

As well as appearing in eight Carry On films, Holloway had parts in numerous TV series, including Doctor Who, Uncle Silas, and Whatever Happened To The Likely Lads?

His film roles included prison comedy Porridge, The Rum Diary starring Johnny Depp, and A Christmas Carol with Jim Carrey.

Holloway was born in Watlington, Oxfordshire, the son of My Fair Lady actor and singer Stanley Holloway and wife Violet.

In his later years, he lived in California and undertook voice


He also had a prominent role in 1960s courtroom film Hostile Witness and appeared in

No more Broccoli: Bond producers hand creative control over to Amazon

BOND fans were left shaken and stirred this week by the news that, after 60 years at the helm, the 007 film franchise will no longer be controlled by the Broccoli dynasty.

Barbara Broccoli and Michael G Wilson the long-serving masterminds behind the Bond films, announced they are stepping down.

The series was launched by Albert "Cubby" Broccoli in 1962, before his daughter and stepson took over.

The pair will now give creative control to Amazon MGM Studios, which was formed when Amazon bought Bond's parent studio in 2022.

The new deal comes after mounting speculation about the fate of the British spy, four years after his last outing in

No Time to Die, which was also Daniel Craig's final appearance in the role.

Amazon will now decide which actor will take over the famous character, but there is still no timescale for when that that will happen or when the next film will be made.

James Norton, Aaron Taylor-Johnson and Theo James are among the bookmakers' favourites to fill Craig's shoes.

A statement said Broccoli and Wilson will "remain co-owners of the franchise" as part of a new joint venture but Amazon MGM Studios "will gain creative control".

Wilson, 83, said: "With my 007 career spanning nearly 60 incredible years, I am stepping back from producing the James Bond films to fo-

cus on art and charitable projects.

"Therefore, Barbara and I agree, it is time for our trusted partner, Amazon MGM Studios, to lead James Bond into the future."

Broccoli, 64, added: "My life has been dedicated to maintaining and building upon the extraordinary legacy that was handed to Michael and me by our father, producer Cubby Broccoli.

"I have had the honour of working closely with four of the tremendously talented actors who have played 007 and thousands of wonderful artists within the industry.

"With the conclusion of No Time to Die and Michael retiring from the films, I feel it is time to focus on my other projects."

Cubby Broccoli launched the iconic franchise with co-producer Harry Saltzman, and was joined by Wilson as a producing partner for

1985's A View to a Kill. Barbara took over from her father to join Wilson as a producer for 1995's GoldenEye, and the pair have overseen

every Bond film since through their Eon production house.

They kept tight control of the character - something that was acknowledged by Craig when he presented them with honorary Oscars in November. "Over the years many people and organisations have tried to put their own footprint on Bond," he said.

"Barbara, Michael, I can't tell you how much I admire your integrity in holding on to your singular vision as you brought Bond into the 21st Century with a passionate and a protective determination to honour the heart of this franchise."

The pair's relinquishing the reins raises the prospect of a rethink and an expansion of the franchise.

The US giant could commission more streaming spin-offs, for example, such as how the Star Wars universe has been expanded on Disney+.

Celtic suffer last-gasp heartbreak in Munich

Celtic's Champions League adventure came to a halt Tuesday night in gut-wrenching fashion as Bayern Munich struck in the 94th minute to deny them a stunning victory in Germany and snatch a 3-2 aggregate victory.

Trailing 2-1 after the first leg of the play-off round at Parkhead, Celtic led when Nicolas Kuhn capitalised on Kim Min-jae's error to give Brendan Rodgers' side a shock lead just after the hour.

That was after a first half in which Celtic passed up four fine opportunities to score - Kuhn, Callum McGregor, and Daizen Maeda, twice, all going close - while England captain

Harry Kane hit the bar before he was substituted at half-time.

Celtic would not be denied after the break, though, when Maeda burst forward and funnelled the ball to Kuhn, who took advantage of Kim's hesitancy to slip past Manuel Neuer.

Bayern, stunned into action, pushed for a leveller. Leon Goretzka nodded wide; Joshua Kimmich forced Kasper Schmeichel into a fine save; and Leroy Sane drilled a shot just past the post.

Celtic were on the back foot, unable to get out of their own half and counter Vincent Kompany's side, and eventually - with extra time within sight - they cracked to

concede with the last kick of the game.

Michael Olise's cross was met by Goretzka, whose header was brilliantly saved by Schmeichel. The ball dropped in front of the empty goal, and Cameron Carter-Vickers' attempts to clear were thwarted by Alphonso Davies, who bundled over the line.

Football is so often a cruel game, and it was hard not to feel for the Celtic players who lay dejectedly on the turf as their Bayern counterparts ran to the corner celebrating, and no doubt breathing a huge sigh of relief.

All the fight and resolve that they had shown for almost 180 minutes had been



A last-gasp goal from Alphonso Davies broke Celtic hearts on Tuesday sapped from them by the scrappiest, ugliest of goals.

The Scottish champions hustled and harried, and stood up when tested. Schmeichel added more saves to his highlights reel, while his defence headed, blocked and cleared almost everything that came at them.

There were chances. McGregor blazed over

in the first half when he should have hit the target. Kuhn had one cleared off the line, before his cross to the back post missed Maeda by a matter of inches.

They forced another opportunity when Dayot Upamecano sliced a pass. Kuhn played in Maeda with Neuer off his line, but the Japanese forward chipped wide.

There is a German say-

ing - coming close is also missing it. It feels harsh to be critical given the monumental effort Celtic produced, but they needed to be more clinical.

This looks like a different team to the one battered in Dortmund just a few months ago. They've matured considerably and look like growing even further.

Although Celtic have been flying domestically and did well in the Champions League group stage, Bayern would have been happy with the draw.

After two gruelling encounters, they will just be happy to have made it through unscathed after an almighty scare.

Celtic manager Brendan Rodgers was understandably proud after the game, telling the assembled media: "It's a mixture of pride, firstly in the performance level. We have to remember this is Bayern Munich and everyone talked about that before the game.

"Performance-wise, we were outstanding, played without any fear. Defended so well, with discipline, pressed at the right moments, gave them issues on that side, and able to be compact and tight in the right moment.

"We didn't give away so much. Harry [Kane] hit the crossbar in the first half but there weren't too many glaring opportunities for them.

"We created really good chances. Second half we to defend more, but we know the game plan. We get in front, deservedly so. It was just about could we get the second one.

"Our European credibility was always going to be important. That's my main takeaway from this campaign.

"We learned some valuable lessons along the way, played some amazing football, and taken on a club of this size and magnitude - a club where one of their players is more than our budget.

"My unswerving plan is to make it a seasoned club at this level, where we can go and really hurt big opponents like Bayern Munich."

Substitute Darwin Nunez missed a golden chance to win it when he blazed over from five yards with 21 minutes left, while Villa's Jacob Ramsey had a goal disallowed for offside.

All eyes were going to be on Rashford as he made his first start for Villa following his loan arrival from Manchester United.

He had not started a game for over two months - since United's 2-1 Europa League win at Viktoria Plzen - and has just completed four games this season.

But the forward was central to Villa's best moments in the first half, his cross deflecting off Van

Dijk, only for the offside flag to curtail the celebrations.

Rashford was a willing runner, prepared to track back, make tackles and has settled well at Villa. It was only to be expected to see him substituted midway through the second half as he regains match fitness.

For the visitors, though, the records just keep coming for Salah.

The Egypt international now has 39 goal involvements in the Premier League this season, netting 24 times and assisting 15, having opened the scoring and set up Alexander-Arnold's leveller at Villa Park.

In the league, 11 teams have scored 38 goals or less - including Villa - leaving Salah in a class of his own this season.

He has also become just the fifth player with more than 15 goals and 15 assists in a Premier League season, along with Eric Cantona, Matt Le Tissier, Thierry Henry and Eden Hazard.

The forward is the first player Premier League history to score and as-

ist in 10 different games in one season. Salah is also the first player to do so in one of Europe's big-five leagues since Lionel Messi in 2014-15 for Barcelona (11).

If his team-mates, especially Nunez, had his quality or composure then Liverpool would

have taken a battling victory at Villa Park.

His stellar season comes amid the backdrop of his contract situation at Anfield, with Salah entering the final few months of his current deal - and he is proving his weight in gold this season.

Rangers' California takeover edges closer

A takeover of Rangers involving the San Francisco 49ers' investment wing is expected to be completed between April and June, sources close to negotiations have said.

There is "broad agreement" between all parties, with current shareholders expected to sell all, or part, of their stake in the club in the coming months.

The prospective owners would acquire more than 50% of the Rangers shares while taking on the debt, much of it owed to former chairman John Bennett.

The Ibrox club trail Celtic by 13 points in the Scottish Premiership and are out of the Scottish Cup after a hugely disappointing defeat by Championship side Queen's Park earlier this month.

Off the field, they posted a net loss of £17.2m in October 2024 despite what they called record revenue and income figures for the year to June.

Paraag Marathe, the Leeds United chairman

and the force behind 49ers Enterprises, the investment wing of the 49ers NFL franchise, is a key player in the prospective Rangers takeover.

He has been described by a source familiar with the negotiations as "front and centre", but there is an as-yet-unnamed investor who is said to be as influential in the deal as Marathe.

As 49ers Enterprises has full control of Championship leaders Leeds after a £170m takeover in July 2023, any investment would require approval from the SFA's board.

It is understood that Dave King, the largest individual shareholder in Rangers, is supportive of the takeover.

The South Africa-based businessman spoke last year about how he believed "investor fatigue" had set in at the Scottish Premiership club.

While other members of the board have not seen eye to eye with King on many issues in the recent past, there appears to be general agreement on the

need for new energy and new money at the club.

The current Rangers board see Marathe and

his team as "serious people" who have a track record in reviving underperforming sporting

institutions, which is how they see Rangers in a changing footballing landscape.

they looked laboured and off the pace, without Vinicius Junior and with Mbappe still finding his feet after his move to Madrid.

Here, Mbappe looked every inch the world-class operator he is, showing class and composure to lob Ederson for his first, then showing superb sleight of foot to bamboozle Gvardiol for his second.

The hat-trick goal crowned the 26-year-old's perfect night, fully

deserving the rapturous standing ovation he received when substituted 13 minutes from time.

Vinicius Junior, Rodrygo and Mbappe form an attacking triumvirate that is a threat to any opponents they face and it was all too much for City, even more so after they lost Stones to injury after only seven minutes.

Real Madrid, the most successful and ruthless operators in the Champions League, look in the mood once more.

City suffer Real demolition

Manchester City's Champions League campaign came to a tame conclusion at the Bernabeu Wednesday night as Kylian Mbappe's brilliant hat-trick inspired holders Real Madrid to a comfortable 3-1 victory and place in the last 16.

Pep Guardiola's side were attempting to reverse a 3-2 deficit from the play-off first leg but this contest was effectively over after four minutes when Mbappe's precise lob from Raul Asencio's pass increased their advantage.

City, with Erling Haaland only fit enough for the bench, saw their plight worsen moments after Mbappe's opener when they lost defender John Stones to injury.

And City's earliest Champions League exit since they failed to get

out of the group in 2012-13 edged closer when Mbappe showed brilliant close control to wrong-foot Josko Gvardiol before beating Ederson after 33 minutes.

The France forward's third came just after the hour with a low shot as City subsided, barely laying a glove on Real all night as they were out-classed.

City pulled a goal back when Nico Gonzalez turned in his first goal for the club after Omar Marmoush's free-kick hit the bar, but it was no consolation on a desperate night for the reigning Premier League champions.

It was a chastening experience for Guardiola, whose discomfort was particularly relished by Real's fans because of his old Barcelona allegian-

es, as he faces a mammoth task to rebuild and restore City to Europe's top table.

Guardiola admitted Manchester City would have to suffer at the Bernabeu - and no-one seemed to be suffering more than the man who must rebuild this fallen side after this dismal defeat.

They were dealt a bitter blow before kick-off when Haaland failed to recover fully from the knee injury he picked up against Newcastle United on Saturday, robbing his manager of his main attacking threat.

The concession of the early goal was the nightmare Guardiola must have feared, his despair flashed on the many giant screens surrounding this magnificent arena.

Bernardo Silva did not have the legs to cope with Real's energy and running in midfield, while Guardiola left Kevin de Bruyne on the bench after he failed to make an impact at Etihad Stadium.

game, while Real keeper Thibaut Courtois was almost a spectator.

Abdukodir Khusanov had a tough night in an unfamiliar right-back role, Real making him a target for so many of their attacks. It was hard

not to feel sympathy for the 20-year-old newcom-

er.

The manner of City's defeat and elimination only confirmed what Guardiola surely already knows - that it is time to usher in a new era following the years of success.

Liverpool eight points clear after Villa thriller

Liverpool moved eight points clear at the top of the Premier League after being held to a gripping 2-2 midweek draw at Aston Villa.

The Reds have not lost in the Premier League since being beaten 1-0 by Nottingham Forest at Anfield in September, but were almost undone by sloppy defending and a lack of cutting edge.

Youri Tielemans and Ollie Watkins cancelled out Mohamed Salah's 29th-minute opener, before Trent Alexander-Arnold levelled 16 minutes after the break.

Having extended their lead over second-placed Arsenal, Arne Slot's side go to Manchester City on Sunday in what could now be a defining week in the title race.

Liverpool hit back, though, with Jota hitting the bar before Salah teed up Alexander-Arnold for a deflected low effort that beat Emi **cont. on page 19, col. 2**
